INSTRUCTOR PREPARATION

- Introduce yourself to the class.
- Provide a copy of the lesson plan to the Examiners. (2 total)
- Advise students of lesson plan objectives.
- Advise students of chapter and page numbers the material is from.
- Teach class with presentation and demonstration.
- Instructors are welcome to use poster boards, flip charts, or mannequins to demonstrate subject matter.
- Instructors should not read from lesson plan.

Lesson Plan should include:

Title, Reference, Objective, Time, Presentation & Demo, Summary, Assignment

GENERAL INFORMATION

- You must have TWO forms of identification: State issued driver's license, LA Wallet, Social Security Card, or Passport

These forms of identification cannot be EXPIRED

- You must have your registration letter from LSBC
- You must be in dress code: All Black, All White, White Top/Black Bottoms, Any color shoe is permitted (closed toe-closed heel), no crop tops, halter tops, shorts, overalls, skirts unless below the knee with leggings, full coverage tops- no cleavage, attached sleeves, no underarms showing, no strapless or sleeveless tops
- You must arrive on time, 8:30am
- 9:00am is the cutoff time for entry, you will NOT be allowed to enter after 9:00am, no exceptions
- All phones and devices are not permitted inside of the testing facility; this includes digital watches, earbuds, earphones, and any other electronic devices. If you have any questions regarding this policy, please contact our testing department prior to your exam day.
- Talking amongst other testing participants is not permitted.
- You must arrive with all tools and items ready to test.
