## TRANSFERRING YOUR LICENSE TO LOUISIANA

Follow the steps below to assist you with transferring your license to Louisiana.

**Step One:** Determine if your license can be transferred by reading the FAQ's and Helpful information contained in Section One. If your license can be transferred, move on to Step Two.

**Step Two:** Determine if you will need to have your licensing state send us an affidavit/certification of licensure by checking the certification list contained in Section Two. If your state is listed, you will need to have the affidavit sent to us as soon as possible. We cannot accept your application until we receive an official copy of the affidavit/certification of licensure from your licensing state. You may call to verify that we have received it. If your state is not listed, you will not need to send in the affidavit/certification and instead we will use the online verification of your licensing state.

**Step Three:** Determine what exams you will need to take by referring to the "Reciprocity by State List." Locate the state that you were originally licensed, and using your initial date of licensure, determine exactly what exams will be required to reciprocity your license. If your state is highlighted, please contact the office to determine what exams you will need to take. Study material, and information can be found on our website at [www.lsbclouisiana.gov](http://www.lsbclouisiana.gov).

**Step Four:** Determine the required fees by using the "How Much Should I Send" worksheet in section three. Please note, the national exam fee should not be sent into this office. Payment should be made directly to the company at a later date.

**Step Five:** Complete the application for reciprocity contained in this packet. If you are required to take the national examination, please complete the application for reciprocity national exam form as well. Gather all the required documents listed at the bottom of the application. We will need your **CURRENT ORIGINAL LICENSE**. **If your state allows you to print your license, the printed license will be considered an original.** Your license will be mailed back to you promptly. Don't forget to include a check or money order for the total amount you calculated in section four. Mail in your application, fees, and all required documents to this office. If your application is approved, you will receive your returned original license, and your exam date(s) in the mail. **If there are issues with the application, such as missing documents, or if we receive the application prior to receiving the affidavit/certification, you will receive your application back in the mail unprocessed.**

### SECTION ONE

#### HELPFUL INFORMATION & FREQUENTLY ASKED QUESTIONS

##### **AFFIDAVITS/CERTIFICATIONS:**

If your state requires an affidavit/certification of licensure for reciprocity, you must contact your state and follow their process for having an affidavit/certification of licensure sent to our board office. Your affidavit/certification must already be in the office before you submit your reciprocity application. If it has not been received when we get your application, we will return your application to you without processing it.

##### **SCORE SHEETS:**

If you have already taken the NIC exam, you will also need to provide a copy of your NIC score. The NIC score sheet can be printed after you have passed the exam. Please contact the company who administered the exam if you cannot figure out how to self-print. You must submit this with your application. If you cannot provide this, you will be required to take the NIC examination in Louisiana.

##### **APPRENTICESHIP/EXPERIENCE:**

Louisiana law requires attending a Louisiana State Board of Cosmetology (LSBC) registered school to be licensed by this board. State law also requires attending a state approved school for license transfers. Apprenticeship and/or experience does not meet this requirement, and therefore, we cannot transfer licenses obtained by years of experience or apprenticeship.

##### **PRACTICAL EXAMINATIONS:**

If your state board does not administer a hands-on practical examination, you will be required to take one here to obtain a LA license. If your state administers a written or computer based practical, or if your school administered the hands-on, written or computer based practical examination, you will have to take a practical examination here. Please refer to the practical exam information to prepare for this exam. This includes instructors as well. The cost is \$25.00 for the practical examination as well as retake exams.

**2. WHAT TYPES OF LICENSES CANNOT BE TRANSFERRED TO LOUISIANA?**

HAIRDRESSING, HAIRSTYLING, HAIR DESIGN, COSMETICIAN, CLASS CA, CLASS CH, AND LICENSES OBTAINED BY EXPERIENCE, AND/OR APPRENTICESHIP. WE ALSO DO NOT ACCEPT THE FOLLOWING LICENSES FROM THE STATES LISTED BELOW:

**3. IF MY LICENSE IS ON THE LIST ABOVE AND CANNOT BE TRANSFERRED, WHAT ARE MY OPTIONS?**

UNFORTUNATELY, THE ONLY OPTION WOULD BE TO FIND A LA SCHOOL TO ATTEND AND CLOCK THE HOURS THAT LOUISIANA REQUIRES FOR THE SPECIFIC LICENSE.

**4. WHY WON'T YOU ACCEPT MY LICENSE?**

LOUISIANA STATE LAW REQUIRES THAT RECIPROCITY APPLICANTS MUST HAVE ATTENDED SCHOOL, THEREFORE INDIVIDUALS WHO OBTAINED THEIR LICENSE BY EXPERIENCE AND/OR APPRENTICESHIP CANNOT TRANSFER HERE. ADDITIONALLY, LOUISIANA COSMETOLOGY LICENSES ARE INCLUSIVE OF ALL BRANCHES OF COSMETOLOGY. (HAIR, NAILS, SKIN) LICENSES THAT DON'T INCLUDE ALL THREE BRANCHES, MORE SPECIFICALLY, THAT DON'T INCLUDE SKIN, ARE NOT EQUIVALENT TO LOUISIANA COSMETOLOGY LICENSES, AND THEREFORE CANNOT BE TRANSFERRED.

**5. DO I FILL OUT BOTH APPLICATIONS IN THE PACKET?**

YES, IF YOU ARE REQUIRED TO TAKE THE NATIONAL (NIC) EXAM YOU SHOULD FILL OUT BOTH. IF YOU ARE UNSURE THEN YOU SHOULD FILL OUT BOTH APPLICATIONS. IF YOU ARE NOT REQUIRED TO TAKE THE NATIONAL EXAM, WE WILL JUST SHRED THE NATIONAL APPLICATION DURING PROCESSING.

**6. DO I REALLY HAVE TO MAIL IN MY ORIGINAL LICENSE?**

YES, YOU MUST MAIL IN YOUR CURRENT ORIGINAL LICENSE. IT WILL BE MAILED BACK TO YOU WITH YOUR EXAM DATE(S).

ALL RECIPROCITY APPLICANTS ARE REQUIRED TO TAKE OUR STATE EXAM. IT IS A 25-QUESTION EXAM BASED ON THE RULES AND REGULATIONS AND IS ONLY ADMINISTERED AT OUR BATON ROUGE TESTING CENTER.
